

# LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL REGULAR MEETING WEDNESDAY, JULY 12, 2017 LITTLE RIVER BAND GOVERNMENT CENTER

#### OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on July 12, 2017. Following are the minutes of that meeting.

Speaker Riley said good morning everybody and welcome to their Council Meeting for July 12, 2017. Riley said they are going to get started this morning with their Opening Prayer and Steve Lewis has volunteered to do that for them. Riley said he thinks Recorder Lewis actually volunteered him.

#### I. Opening Prayer

Steve Lewis offered the Opening Prayer in Anishinaabemowin.

Steve Lewis' prayer was conducted from the audience and it wasn't picked up on the recording.

Speaker Riley asked Steve Lewis if he could come up to the microphone if he had anything else to share.

Steve Lewis said hello, he is not used to these things but.....he was just going to share a little something with them that their Grandfathers said in a ceremony. Lewis said when he says Grandfathers that means the Spirits or could be translated as Angels. Lewis said so when they said that since human beings aren't respecting the earth they are disrespecting the earth so the Grandfathers say that the Creator is going to help them purify the earth. Lewis said he said watch the sky, just watch the sky, and they will see what they mean when the time comes. Lewis said Miigwech.

Speaker Riley said Miigwech for that.

Speaker Riley said they have their Budget Coordinator here to represent this item and that he had the floor.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said good morning and as they mentioned in Agenda Review these funds are being received from the Natural Resource Conservation Service through the U.S. Department of Agriculture. Willis said this has been an on-going Reforestation Project and these are primarily funds that they get reimbursed for work they already accomplished. Willis said they just need to accept the funds and amend the Operating Budget. Willis said the funds are going into Professional Fees and Supplies.

Willis said it is kind of a compliment to the actual Elders Meal Program. Willis said once again they just need to accept the funds and amend the Operating Budget in the amount of \$6,382.

#### V. New Business

A. Approving Amendments to Housing Regulations Chapter 2-Admission Procedures for Low Income Elder and Tribally Owned Homes The Housing Commission approved certain amendments to the Housing Regulations Chapter 2 and Tribal Council believes the Proposed Amendments are in the best interest of the Tribe.

Speaker Riley said this is one of their Housing Commission's Liaisons have a quick run-down for the membership as to what this is.

Councilor Wittenberg said this is an update on, excuse him....he seen Speaker Riley looking and nobody was answering so he thought well..... Wittenberg said anyway this is an update in rewording of the regulation basically it's the same but this rewording they don't need all the words to say one thing so.

Speaker Riley said okay and thanked Councilor Wittenberg. Riley recognized Shayne Machen.

Shayne Machen, Unified Legal Department Attorney, said in addition, just for a clear record, they have taken the credit history portion of the application which was previously required and they made it optional. Machen said in doing that they had to change a couple of sections in the regulation and it just includes a section that says a final determination on suitability will result in an applicant's removal from the Waiting List so basically if an applicant has a conviction that would preclude them from ever living in homes or preclude them from living in homes for a significant period of time rather than keeping them on the Waiting List and going through the Suitability Process every time they are just removing them from the Waiting List and they can apply at a later date when they would actually be qualified for it. Machen said so those are the two major changes.

Speaker Riley thanked Shayne Machen.

Councilor Wittenberg thanked Shayne Machen.

Speaker Riley said to Ogema Romanelli that he had the floor.

Ogema Romanelli thanked Speaker Riley. Romanelli said well their pow wow is over and it was well received this year he thinks. Romanelli said it looked good and most people were pleased with the upgrades that went on with the concrete sidewalk and all that so. Romanelli said all and all very good. Romanelli said the one concern.....he does have one person that didn't like the concrete and thought they should remain pretty much......more natural but that was one out of about 40 people that he talked to. Romanelli said there was no room for the public to sit and that was one concern that they had because there were the tents that were set up all around the circle and allowed very little room for the guests to watch and

view. Romanelli said he guessed there was normally more bleachers than there was this year so he suggests.....he would suggest even more they should have one set at least for the Elders that he remembers and maybe a couple of others for other people at a minimum. Romanelli said he sees questions and hands going up.

Speaker Riley recognized Recorder Lewis then Councilor Di Piazza.

Recorder Lewis said yeah she knows many put shades up but people are polite so if they wanted to come in but for a future project they should think of a design where they put a shade around the whole area for people that are spectators. Lewis said she thinks that is something they should keep in mind is just put a shade up around the whole area to make sure everybody is comfortable in there.

Ogema Romanelli said okay by shades Recorder Lewis means......

Recorder Lewis said where they put posts.....

Speaker Riley said a roof that goes around that thing.

Recorder Lewis agreed a roof that goes around the whole area so everybody is comfortable and shaded well and not getting sun burnt. Lewis said they don't want their Elders out in the heat. Lewis said the sidewalk is really amazing because it does provide access for people that are handicapped or Elders. Lewis said it makes it much easier for everybody to get around.

Ogema Romanelli said stable footing.

Recorder Lewis said it welcomes everybody so.

Speaker Riley recognized Councilor Di Piazza.

Councilor Di Piazza said yeah he requested a work session after pow wow. Di Piazza said no big complaints and everybody that he talked to, vendors and everybody, liked the new process, the concrete and how people get around. Di Piazza said there are some tweaks he could that he heard from the vendors and people around but no big deal. Di Piazza said it is just another learning process which he hopes they keep going that way.

Speaker Riley recognized Councilor Lonn.

Councilor Lonn said she agrees she missed the bleachers because the Elders.....that section was full and so other Elders were trying to find a place to shade and they couldn't. Lonn said a lot of them don't realize that they can sit underneath the other tents but they need those other bleachers up as well.

Ogema Romanelli said okay and that should be brought up at the work session he would hope, good.

Speaker Riley recognized Councilor Wittenberg.

Councilor Wittenberg said he agrees with them he would like to see himself even broadening for the Elders and he thinks up in the Elders Section where they.....he doesn't think there was even a sign up for Elders Only. Wittenberg said people didn't know and he said kind of to himself that it was a minor technicality but he is sure next time it would be.....he thinks it would be awesome to have a broader \_\_\_\_ around. Wittenberg said there are more Elders now as a part of their Tribe and so.

Ogema Romanelli said he thinks designated area maybe two sets of bleachers for them and a couple of others. Romanelli said again he is understanding that the cost of the bleachers isn't really that significant in the scheme of things. Romanelli said yeah and a designated area for their Elders.

Speaker Riley said they can cover this stuff in the work session that they are going to have and the public can too so. Riley said to Ogema Romanelli that if he wanted to carry on with his report.

Ogema Romanelli said yes they have the Bike Time coming up this weekend and he knows that they have several employees going and Council members. Romanelli said he appreciates that. Romanelli said a lot of travel going on with their Elected Officials over the next couple of weeks himself included. Romanelli said they have several different things that they are attending. Romanelli said the parade was well received to his understanding and he wanted to thank everybody that worked on the parade including those on the.....over at the casino side but they were asked to join other parades. Romanelli said he was not a part of it but it sounds like it was well received and so thanks to everyone that was involved with that. Romanelli said he thinks that is it.

Speaker Riley thanked Ogema Romanelli. Riley asked any other questions for the Ogema.

#### C. Legislative Affairs Update

Speaker Riley said one of the great things about that it would allow them to issue bonds tax free which is, as most people know, that is how cities fund a lot of their projects is by doing Municipal Bonds.

Councilor Crampton said his whole point is that there seems to be a full court press going on in every area of the government and with their travel this week and going to the Democratic Retreat this is where they need to hammer down on these guys.

Speaker Riley asked anything else for Legislative Affairs. Riley recognized Councilor Di Piazza.
