COURT POLICY

- PARTIES AND WITNESSES MUST APPEAR BY VIDEO. If you do not have video capability, please obtain approval from the court prior to the hearing to attend without video.
- ALL ATTENDEES MUST CHANGE THEIR PHONE NUMBER TO THEIR NAME PRIOR TO THE START OF THE HEARING. If you do not have the capability of doing so, please contact the court and provide your phone number prior to the hearing.
- Upon entering the hearing, you will be placed in a "Waiting Room" until the Judge is ready to begin the proceedings. <u>Please connect to the hearing early. If you connect</u> <u>after a hearing has already begun, there is no guarantee you will be admitted to</u> <u>the hearing.</u>
- The Zoom hearing is an official court proceeding and therefore an extension of the court room. Appropriate conduct and attire are required.
- The judge has the same authority over the virtual court participants as if they were physically present in the courtroom, including the authority to hold someone in contempt of court.
- Any messages or conversations not a part of the official court proceeding between the client and the attorney should take place outside the virtual courtroom. A request can be made to the Judge to enter a "Breakout Room."
- Photography, recording or broadcasting of any hearing is strictly prohibited. (*Rules of Civil Procedure, CR 4.015*)
- Remote participants must use a private and quiet room that will be free from interruptions. Avoid rooms with bright windows or back lighting. Attendees who are not parties to the case should keep their microphones muted throughout the hearing.
- The court does not provide technical assistance for testing or troubleshooting.
