A. Grants & Contracts

1. Approval of Submission of Grant Application to the United States Environmental Protection Agency-Performance Partnership Grant Program for Federal Fiscal Years 2019 and 2020

This is the Bi-Annual USEPA grant application to fund Water Quality, Brownfields and GAP Programs. This Grant also funds 3.3 Positions in the Natural Resource Department.

Speaker Riley said Allison Smart has got this one and that she had the floor.

Allison Smart, Environmental Coordinator, represented this agenda item. Smart said good morning Council and Tribal Ogema. Smart said today with her she actually has some of their representatives from USEPA who help manage this program. Smart said she has Jenny Manville their Tribal Liaison. Smart said Dan Samardzich who is the Project Officer for their PPG's and Lauryn Coombs who is the Project Manager for the Brownfield Programs. Smart said they are here today doing an Advanced Monitoring Visit with just kind of going over their current grant with them. Smart said they get to help and come see how they get these approved. Smart said today she brings forward their bi-annual application for FY19/20 for their PPG Program which combines their Clean Water Act, CERCLA and IGAP Funding. Smart said the total amount for two years that is EPA funded is \$817,534 with a total match requirement of \$20,526. Smart said with that is there any questions.

1. Acceptance of contract funds from the Department of Health and Human Services-Indian Health Services and approving a modification to the Operating Budget MB-2018-__ in the amount of \$60,000

The Tribe has received additional funding for the Well & Septic Program.

Speaker Riley said Bill Willis is representing this and that he had the floor.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said good morning and thanked them. Willis said these funds represent a new award he believed from the Department of Health and Human Services for the Well & Septic Program. Willis said these funds are specifically earmarked to provide either well or septic and/or both for three new homes. Willis said it is in the amount of \$60,000 and the program runs from July 1st of this year through December 31st of 2020. Willis said they just need to accept the money and amend the Operating Budget.

Willis said the funds are earmarked for Fish Hatcheries Maintenance. Willis said year to date it brings them up to \$1,124,973. Willis said they estimated in the 2018 Budget that they would receive \$1,923,539 so they are well on their way to receiving what they anticipated.

5. Approval of Budget Modification MB-2018-__; Authorizing a modification to the Public Information Office Budget to better meet the roles and responsibilities of the department

Tribal Council must approve any change in the scope of a program such as the elimination of program activities.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said as Council is aware there has been a number of changes in regards to the Currents and how they distribute those. Willis said there was a survey he believed sent out a while back to let Tribal Members decide whether or not they still wanted to receive the Currents via mail. Willis said there has been a number of changes and they no longer use an outside consultant to print the paper they do in-house. Willis said given those changes they obviously need money in other areas now than they did before such as for paper and ink and stuff like that. Willis said so that is what this is really about. Willis said Rebecca Groh who is doing the paper is here should Council have any specific questions about details, etc. Willis said they are just moving money around to where they need it.

Speaker Riley said okay. Riley asked are there any questions or a motion. Riley recognized Councilor Di Piazza.

Bill Willis said he means that is more specific to the ordinance but obviously they are not sending out......they used to send out how many papers....

Rebecca Groh, Administrative Assistant, said 3,100.

Bill Willis reiterated 3,100 and they are only sending out 600 or so now. Willis said those are the kinds of reductions or changes in the program that are substantial. Willis said Council really needs to weigh in on that so. Willis said he doesn't know if they have any other......

Rebecca Groh said it is not so much anything being moved it is actually just a technicality to move the funds that were set aside for the third party that designed the paper over to different accounts for purchasing paper.....for the paper here,

the ink because it is.....it is basically a technicality to take those funds that were set aside for the third party and use them towards purchasing the paper to print here, purchasing the ink so it is not coming from the General Budget or the Building Budget so nothing is being taken away or added just moving it around for the technicality of what......Accounting......GL Accounts where the money actually goes and what it is purchasing.

Councilor Crampton said okay.

Wheeler said as mentioned it covers the Tribe, Little River Holdings, LLC, Muskegon Gaming Development for their General Liability, Property Insurance, Crime, Auto, Worker's Comp and this is all through the Tribal First Insurance Company and administered by their Agent Stephen Madigan, LLC. Wheeler said as covered in the Agenda Review the annual wise cost for the premium is \$302,136.

To support Food Vendors and provide guidance on such sales on Tribal and Trust Lands, Food Vendors or Operations that meet the standards of a Cottage Food Operation and maintain compliance in accordance with the Michigan's Cottage Food Law, PA 113 of 2010, shall be exempt for additional Food and Safety Licensing and inspection Requirements. Such exemptions do not include additional licensing or procedural requirements mandated by Tribal Law, including certain Tax Licensing Requirements.

Speaker Riley explained what falls under this is uncut fresh produce. Riley said basically anything that they pick out of a garden as long as it isn't sliced up, diced up or cut up it has got to be whole then it is exempt from all the Food Safety Requirements for preparation of foods. Riley asked is there a motion or any discussion on this item. Riley recognized Recorder Lewis.

Recorder Lewis said she would like to make a motion.

B. Ogema Weekly Status and Business Update

Speaker Riley said to Ogema Romanelli that he will let him have it, sir.

Ogema Romanelli thanked him. Romanelli said he has three items. Romanelli said they know that the Pow Wow is coming up this weekend and just as a reminder to everyone. Romanelli asked what else do they have going on. Romanelli said they should be having the things at the Lodge, right, the Talking or has that not happened.

Councilor Di Piazza responded no.

Speaker Riley said that only happens at the Fall and Spring Membership Meetings.

Ogema Romanelli said he thought they were also talking about having one here but anyway. Romanelli said the Speaker and he spent several days in Martha's Vineyard this year last week and they spoke with some of the elected Representatives, Senator Stabenow, Senator Peters and he met some people that he hasn't seen in a while in the Obama Administration including Charlie Gilbreth, etc. Romanelli said he thinks they got their point across which is what they intended to do. Romanelli said the only other item he has is he sent out an e-mail in response to the e-mail that was sent out earlier regarding the 2% that was sent out to all LRBOI. Romanelli said he doesn't know if Council has any questions but that would hopefully explain how this happened. Romanelli asked any questions.

Speaker Riley said he doesn't have anything.

C. Legislative Affairs Update

Speaker Riley asked does anybody have anything for Legislative Affairs. Riley recognized Councilor Crampton.

Councilor Crampton said yeah last night probably one of the most exciting things that he has ever seen in New York......in politics has happened. Crampton said a person who didn't have money or political background stood up with a message in New York and beat a long standing Democrat that outspent her 18 to one. Crampton reiterated 18 to one. Recorder Lewis said she just wanted to say a little bit more on what is going on this weekend and they do have a lot of activities. Lewis said they start out Friday evening from 7:00 until 10:00 there will be a Kid's Dance. Lewis said Saturday morning about 7:30 or 8:00 people will be meeting over at the Casino for the Wellness Walk. Lewis said Council will be serving a Feast at 5:00 on Saturday. Lewis said to Ogema Romanelli that he was more than welcome to join them and help serve on that if he is available. Lewis said the Pow Wow is going on all weekend and starts Grand Entry about 1:00 Saturday. Lewis said she suggests being there around noon especially if they are dancing. Lewis said Grand Entry will again be about 7:00 Saturday evening and then it will start again Sunday around noon.

Speaker Riley said he just has a public comment related to Council serving the Feast he knows there is a lot of people that do appreciate that they get out there and do that but there is also another group of people that feels like what they are doing by giving away free food is taking away from their own vendors opportunity to make money. Riley said he would like to hear from people to see where exactly that goes. Riley recognized Recorder Lewis then Councilor Wittenberg.

Recorder Lewis said they been kind of in the middle of something because it is kind of like they present themselves as being a Traditional Pow Wow and then they kind of present themselves as being Contest and is not one or the other. Lewis said they are kind of an in-between and usually when they have people coming in from long distances regardless they want to make sure that they are taken care of. Lewis said they are not trying to like hurt any of their vendors but really when they do have people coming in from other communities they want to be hospitable and to take care of some of their needs. Lewis said make sure that they are welcomed and are comfortable.

Speaker Riley said he agrees with her 100%. Riley said he is just saying that he heard it from both sides and would like to hear more from people on it. Riley recognized Councilor Wittenberg.

Councilor Wittenberg said yeah himself he thinks it is a great honor to do that for their people and all people. Wittenberg said he knows going down to G.R. Pow Wow.....Grand Rapids Pow Wow they do the same thing. Wittenberg said they feed their dancers and everybody that is there. Wittenberg said it is what it is. Wittenberg said he is all for it.

Speaker Riley recognized Councilor Crampton.

Councilor Crampton said he just wanted to add something about the vendor's verses Council thing. Crampton said he sees what Speaker Riley is saying and he doesn't want to cheat the vendors out of it but he thinks that day is one of the days that he really likes because most of the times people get elected and he doesn't know what the perception is that they are somehow above the membership when actually it is supposed to be the total opposite. Crampton said they are supposed to be elected to set the table for the people. Crampton said he thinks this is one way they get to show that they are not above the people and they serve them.

Speaker Riley said alright and thanked Councilor Crampton. Riley asked anything else for public comment.
