## **Position:** Lead Cook (FT- NGLC - Family Services Department) – 1 Opening

**Summary:** Monitor kitchen operations for the Next Generation Learning Center to ensure the quality of food. Responsible for the proper preparation and serving of meals. Maintaining a safe and sanitary work environment and comply with applicable laws, regulations, and performance standards as they relate to internal policies and grant requirements. Research, order, and inventory all food for the NGLC nutrition program.

Employment Qualifications: A qualified candidate offers:

- High School Diploma or GED; and
- Four years of increasing responsibility cooking in a commercial kitchen serving 100 persons or more on a regular basis; or Associates Degree in Nutrition, Food Service Management or related field and two years of increasing responsibility cooking in a commercial kitchen serving 100 persons or more on a regular basis; and
