Position: Maintenance/EVS Technician – Health services – Muskegon FT

Summary: The position is responsible for the completion of maintenance requests within the Little River Health Center of Muskegon, and for maintaining a safe and properly functioning work environment. The position is also responsible for performing routine and repetitive cleaning activities within Little River Health Center of Muskegon. Travel may be expected between the Muskegon and Manistee Health Centers or any additional request by Supervisor and/or Director of Health Services.
