Position: Maintenance Technician - Maintenance – Updated (2- Full Time - Regular)

Summary: The position is responsible for the completion of maintenance work order requests within assigned areas, and for maintaining a safe and properly functioning work environment.

Employment Qualifications: Minimum Necessary Qualifications -

- Minimum of 18 years of age; and
- A High School Diploma or GED; and
- A work experience of two (2) or more years, or equivalent combination of work and training in the maintenance field (experience in snowplowing or willingness to learn); and
- A valid Driver License (w/CDL endorsement preferred) with the ability to be insured under the Tribe's insurance policy.
- Superior performance in the selection process as determined at the sole discretion of the LRBOI Hiring Manager, including but not limited to all of the following: any pre-employment interviews, skills testing, credentialing, drug screening, background investigations, reference checks and previous work history, passing a pre-employment drug test and background investigation, possession of a valid Driver's License throughout employment and being insurable under the Tribe's insurance policy.
