Reconsideration for adopting the amended fiscal year 2022 Tribal Government Operations Annual Budget as Presented by the Tribal Ogema.

This is the reconsideration of the previous resolution that the Ogema vetoed go over for the people participating today that tribal council of the Little River Band of Ottawa Indians is exercising their power to adopt approve and amend the annual budget presented by tribal Ogema approved the amended fiscal year 2022 tribal government operations annual budget as amended in the amount of \$46,219,278 with gaming distribution estimated at \$30,188,604. That's my introduction to the item open it up for just ask if any tribal members our tribal council is going to abstain from the item? any tribal council is going to abstain from the item? seeing or hearing that I will open it up for discussion amongst tribal council? any comments or questions by tribal council? Seeing or hearing none

Nitumigaabow Champagne: temporary speaker um councilor Wolfe I would like to call the Order uh miss councilor DiPiazza and Guenthardt are having a conversation uh is that part of the record? Call the order ma'am

Acting Speaker Wolfe: I didn't hear anything but thank you. I didn't hear any conversation.

Councilor Guenthardt: Get the shit out of your ears

Acting Speaker Wolfe: So, it is open for discussion up by tribal council? seeing none I will open it up for discussion with participants on the call only seeing first in queue I have Nitumigaabow Champagne

Nitumigaabow Champagne: thank you councilor Wolfe. Councilor Guenthardt, please note for the record uh using profanity is not appropriate or acceptable in any council meeting to constituents me being one of them as a nine county represent nine county uh votee so with that being said I'd ask madam recorder to please address that with councilor Guenthardt to refrain from profanity during this meeting. Moving on to the budget the budget that has been proposed by uh yourself does not appear to be the same budget that was proposed by tribal council as a body, I have serious concerns and numerous different areas that is done I'm not sure if all the tribal council members have received the budget prior to calling the meetings and your first vote if not I feel that is very concerning actions on behalf of that administration. I'm concerned that specifically uh council previous budget allotted 10,000 dollars for the executive side for litigation purposes if there was an issue that the Ogema need to go for council. I'm concerned that tribal council still does not have legal counsel the Ogema has previously filed prematurely to block ULD amendments to ULD funding places tribal council and the citizens and this tribe at risk as apparent in DiPiazza versus uh tribal council, tribal council did not have legal representation to even represent matters because of the lack of funding and the lack of having an attorney. This is concerning when the tribe is not able to have legal representation for seeds on litigation matters. I think this needs to be addressed in your budget for 2022. I'm also concerned about other areas of the budget

that you have amended. I believe that the discussions uh were not done in work sessions for the citizens to participate in the back room deals with Mr. Romanelli uh between yourself madame recorder and Mr. Romanelli to be able to reach these agreements or businesses council and Mr. Romanelli I think that it needs to be in front of the citizens so that citizens are able to um weigh in previously when the budget had the casino in it was in closed it made sense it doesn't make any sense for the budget means to happening in closed if the casino numbers are not in and so I questioned that practice that this administration has done. I would also question the changes that you're proposed I would ask that Mr. Pringle would it be possible to go through the proposed changes amended from the first amended response to Mr. Romanelli?

Acting Speaker Wolfe: is that your final comment.

Nitumigaabow Champagne: It's a question madam recorder or miss uh councilor Wolfe

Acting Speaker Wolfe: Well, what's the question? I didn't hear a question in there Councilor DiPiazza: She is the acting speaker she needs to be addressed accordingly

Nitumigaabow Champagne: Mr. DiPiazza I don't think you're in queue. I was asking the question if Mr. Pringle or yourself can go through the budget changes specifically that are different from the amendment budget? I would call to order that Mr. DiPiazza is interrupting my turn

Acting Speaker Wolfe: I don't believe at this time it's necessary to go through additional changes so moving on in queue we have Antonio Romanelli you're next you have the floor

Antonio Romanelli: Antonio Romanelli 3954 um yes, I just I have concerns over um the tribal councilors that don't show themselves on the video when they're not in session if they could turn their video on, I would greatly appreciate that I have some great concerns that um you know that there might be people in the room that that shouldn't be on this call, so I have great concerns for that thank you

Sara Agosa: Sara Agosa 4478 my comment is that I would like to request that tribal council delay this vote and maintain the original vote um that occurred before the stay was granted and I'd like to request that tribal council dispute the stay um and that membership is entitled to that original vote that is my comment thank you
