 - Fall self-goverence conference

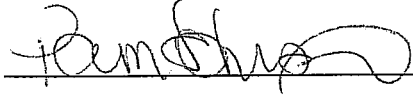
Motion to adjourn by Johnson Seconded by Patricio, all in favor. Meeting adjourned at 6:07 pm.
