

# LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL REGULAR MEETING WEDNESDAY, MAY 23, 2018 LITTLE RIVER BAND GOVERNMENT CENTER

#### OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on May 23, 2018. Following are the minutes of that meeting.

Recorder Lewis said to Speaker Riley that the recorder is on.

Speaker Riley thanked Recorder Lewis. Riley said he would like to welcome everybody to their meeting for May 23<sup>rd</sup>. Riley said they are going to get started with their Opening Prayer and believes that Grace Hendler is going to do that for them today.

### 2. Approval to submit an Enterprise Section 4 Grant-Aki Phase 4 Utility Design Completion (Electric and Gas)

The Tribe currently has plans for Sewer and Water Infrastructure and is in need of awarding grants up to \$50,000 for this purpose. There is no matching requirement by the Tribe.

Speaker Riley said he just paused there because it doesn't make a lot of sense to him but it looks like Lyle Dorr their grants person is going to represent this. Riley said to Lyle Dorr that he had the floor.

Lyle Dorr said the other side of it is and he thought he redid......that is a different one that got into.....he had sent one through. Dorr said there is a match that he mentioned at the meeting there is a 3-1 match on that grant. Dorr said it is for the planning pieces to get them ready for actually completing the project and hopefully within a couple of years they can get some funding to start those on the back end. Dorr said the other one is Gary Lewis was in with them so when he started to leave he came in and met with him. Dorr said Gary Lewis said their department has some unfinished business with planning to the tune of like \$27,000. Dorr said he put in there \$50,000 because that was going to be more than enough for what they needed but potential for the grant is up to \$100,000 and they could incorporate his stuff into it. Dorr said he doesn't know how much it would be and he is thinking between the two of them maybe \$60-70,000. Dorr said he would like to be able to modify that request for the application.

Speaker Riley said okay and is there any discussion or a motion on this. Riley recognized Councilor Pete.

Councilor Pete said okay he will make that motion.

# 3. Approving Grant Application for the FY2018 Grants to Tribal Governments to Exercise Special Domestic Violence Criminal Jurisdiction Solicitation

Through this Grant Program Indian Tribes receive support and technical assistance from planning, developing, and implementing changes in their Criminal Justice Systems necessary to exercise SDVCJ.

Shayne Machen, Tribal Prosecutor, represented this agenda item. Machen said correct, good morning and thanked them for having her. Machen said this grant will allow them to begin the changes to the Criminal Justice System and their laws that they need to change to implement what is commonly referred to as VOWA. Machen said that is basically just the ability to prosecute Non-Native Offenders who commit Domestic Violence, Stalking, Dating Violence, Intimate Partnership Violence or PPO Violations on Tribal Land. Machen said so there is no match to this grant and is a competitive grant and they are planning to offer ten awards between \$300,000 and \$450,000. Machen said her hope is they can use the money to make the changes that they need to change to their system.

Speaker Riley said now he has a question because this is the one where they need all their judges to be law-trained or is that a different one.

Shayne Machen replied they need a law-trained judge to oversee these cases.

Speaker Riley said just who oversees the case has to be a law-trained judge.

Shayne Machen said correct so she is in the process of creating an MOU that the court would agree to either use a law-trained judge or to bring in a visiting judge who is law-trained to oversee the cases.

Speaker Riley said okay. Riley recognized Councilor Crampton.

Councilor Crampton said maybe he is wrong but he was under the impression that if they were going to do this that they needed absolute parody with other courts in the way of Public Defender or Public Defense for the.....

Shayne Machen said it is not absolute parody there is like a list of things they have to do so they do need a Public Defender for indigent defendants. Machen said they do need the right to a jury pool that includes not just Natives so her plan would be to include anyone who is working on the Reservation that includes Casino Employees. Machen said that is the way the Nottawaseppi is doing it and that is the way a number of the other Tribes around the country who have casinos under their jurisdiction are doing it is to create a kind of wider pool of jurors.

Speaker Riley said just.....just to add to that. Riley said they actually in this year's Budget Council did ask for money to be set aside for indigent defense in

their Court System so that is already something that is being worked on. Riley said he doesn't think they have agreements just yet do they.

Shayne Machen answered no.

Speaker Riley said okay. Riley asked any other discussion or a motion. Riley recognized Councilor Friedel.

Councilor Friedel said if there is no further questions he would like to make a motion.

Recorder Lewis said she would like to make a motion.

Speaker Riley asked are there any abstentions or any further discussion on this one. Riley said actually he has a question for....okay Councilor Crampton go ahead.

Councilor Crampton said he just wanted to let the Council know that he will probably be attending this too but he is not going to put in for travel because if he can't get there when he \_\_\_\_ from his house but the reason he wanted to attend this is he had a discussion in Washington on this very subject. Crampton said he thinks they are going in the wrong direction because they are looking at treatment and what happens afterwards. Crampton said the question he asked on this Opioid Epidemic is this is not something or not a business where they advertise and don't take out a billboard and they don't take out a commercial. Crampton said it is friend to friend \_\_\_\_. Crampton said people know who these people are that are bringing death to the Reservation and they need to confront it there at the doorstep. Crampton said they don't need to look for treatment in costly measures and need to start taking responsibility.

Speaker Riley recognized Recorder Lewis.

Recorder Lewis said she just wanted to add to that. Lewis said when she was out in Washington, D.C. giving testimony she did speak about the Opioids and a lot of it is planting a seed and nipping it before it even happens. Lewis said they really need to give their people hope and they need to give them goals and something to look forward to is what she had stated out there so she is in full

support of it by educating their people, getting them trained or whatever it is they have to do so they don't even want to go down that road.

Speaker Riley recognized Councilor Wittenberg.

Councilor Wittenberg said yeah and that is.....he knows himself he has been attending these different Opiates not only South Carolina then Washington and then here in the community. Wittenberg said it is true that this one here all the Tribes are getting together and seem to acknowledge what is going on within their Tribes but also they are absolutely right it is that after care. Wittenberg said they can go into treatment and can stay in there but it is what is going on afterwards and that is what they need to, he feels, look at also. Wittenberg said he knows himself the different Opiates Conferences that he has been to that has been brought up that it is the after care and what the people do and they have to fill it back in where the Opiates were taking its place.

Speaker Riley said there is a couple of things that....one of the things that he is disappointed with this whole initiative and it is overall it is not with the education piece or anything like that it is the fact that once they get the government involved in these things what they do is lump everybody up into a group. Riley said from what he is hearing from certain people that he knows and from doctors that he knows is that they are being placed on strict quotas as to how much they can give out which completely rules out the individual circumstances. Riley said a doctor who has been in practice for longer will tend to have more Elderly patients and more people who are receiving end of life care and have pain management issues. Riley said where somebody who has been in practice for a couple of years is going to have less than that.....far less than that. Riley said he thinks when they start to group everybody up rather than look at individual circumstances he thinks it just is wrong. Riley said it is something that is bad from every standpoint that he can think of because every person has different circumstances and it is not to take away from the overall issue that it is an epidemic but he thinks that the focus on the individual here needs to be what prevails because everybody that has issues with this might have it for a different reason and it is not.....there is not a one size fits all fix to this problem. Riley said that is all he has to say about that. Riley asked is there any other discussion. Riley recognized Boo Battice.

Boo Battice, Tribal #2644, said he would like to thank them for putting all the efforts they can within the last month three of the people he knew and grew up with in the town actually overdosed on Heroin. Battice said they do need to pay as much attention as they can and he would like to thank them guys. Battice said just a little bit of FYI watching a show the other day on studies of drugs they put a bunch of rats in the same size cage with water, drugs and they ended up going to the drugs because of boredom. Battice said they put the rats in another cage with a wheel, things to do, toys, and only one out of the rats ended up going to the drugs. Battice said if they can find things for these people to do instead of drugs helps. Battice thanked them for all their efforts.

Speaker Riley asked was it double blind or was there a confirmation study done or is this just where the findings are singular in nature.

Boo Battice answered this study was done back when Nancy Reagan did the "NO" on drugs. Battice said it was done a long time ago where they keep the people's brain busy instead of.....instead of pushing to drugs they do it because of boredom a lot of the times and they can't afford to go have fun.

Speaker Riley said he thinks it makes a lot of sense but there is a lot of times they often times fall victim to confirmation by them too so it.....he means he thinks there is a point there and thinks what Boo Battice is talking about a contributing factor to the overall problem. Riley said he thinks that is just a small part of it. Riley thanked Boo Battice for sharing that.

Boo Battice said he would like to thank them again for pointing out that yes every individual is an individual.

Speaker Riley recognized Councilor Crampton.

Councilor Crampton said he just wanted to add that he is aware of the study that Boo Battice is talking about and there had been similar studies but since the Reagan era the potency of even Marijuana has gone up exceedingly above what it was before.

Boo Battice said the episode that he was watching was only testing Opiates and not testing any other drugs.

Councilor Crampton said the potency of that has gone up too.

Boo Battice said yes and thanked Councilor Crampton.

Speaker Riley thanked Boo Battice. Riley said if there is no further discussion. Riley asked Recorder Lewis to do a roll call.

# A. Resolution to Require the Tribal Court to Report all Tribal Court Convictions to Michigan's L.E.I.N.

The Michigan Law Enforcement Information Network is a statewide computerized information system that serves Michigan's Criminal Justice Agencies by maintaining a Filing System of accurate and timely documented information readily available to all Criminal Justice Agencies. Tribal Court wants to report convictions to ensure the safety of its Members and Community.

Speaker Riley said Shayne Machen is representing this one as well and that she had the floor.

Shayne Machen, Tribal Prosecutor, represented this agenda item. Machen said good morning again. Machen said the LEIN System that Michigan uses is the statewide data base that houses all of the criminal convictions that occur in State Court. Machen said that data base forwards those convictions to the FBI for their data base and to NIX which is the data base that everybody uses in Michigan to conduct background checks if they wanted to purchase a firearm. Machen said currently the Tribal Court doesn't uniformly forward convictions to LEIN which they \_\_\_\_\_ sometimes where they have people who have been convicted of violent offenses and nobody but the Tribal Court knows about that. Machen said she had listed a number of reasons in the resolution why this is concerning for Domestic Violence Victims or Victims of Dating Violence or issues like that. Machen said so the resolution would require that all convictions whether for citations or misdemeanors be forwarded to the LEIN System so that the other Law Enforcement Agencies have knowledge of them.

Speaker Riley recognized Councilor Pete.

Councilor Pete thanked Speaker Riley. Pete said just a comment from his understanding in their meeting is that basically what happens is right now in Tribal Court is someone is convicted of it it doesn't go out to the State Court so if someone is convicted in the State Court is looked at as a first offense instead of possibly a second offense is that true.

Shayne Machen said that is correct. Machen said the Tribal Court forwards them on a case by case basis. Machen said some convictions are forwarded and some aren't but that is correct. Machen said there is the case where they may not be aware to look at the Tribe for Domestic Violence Conviction and so their second Domestic Violence Offense would be considered a First Offense.

Councilor Pete said so by passing this though and having that it will ensure that all those cases are forwarded to the link, right.

Shayne Machen said starting today.

Councilor Pete said perfect. Pete said to Speaker Riley that he will make a motion.

Speaker Riley said go ahead.

Parsons said he apologizes for getting it to them this late but there were some complications in getting the documents just so for the BIA to accept. Parsons said essentially what this is is they will be having a Construction Project done at the Casino Resort hopefully beginning sometime in June. Parsons said what it is going to be is basically a reconstruction of the ring that goes around the outside of the front of the building and then the parking lot that sits inside that ring road. Parsons said because the Casino Resort is on Tribal Trust Property the BIA is involved in this as they would be in any other trust issues. Parsons said it gets complicated because in essence they are going to be sending a resolution or he will be sending it on their behalf to the BIA requesting a Right-of-Way which they will issue back to them. Parsons said attached to the resolution is going to be a survey of the property, property description and essentially the boundaries of the Right-of-Way they are going to be granting to them. Parsons said he will leave it there and see if they have any questions.

Authorizing the Unified Legal Department to include Little River Band of Ottawa Indians as a Signatory on the Amicus Curiae Brief in Support of Defendants in Brackeen v. Zinke, No. 4:17cv-00868 (N.D. Texas)

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) of the Constitution to provide for the public health, peace, morals and education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized by Article IV, Section 7(e) to employ legal counsel; and
- WHEREAS, Plaintiffs in *Brackeen v. Zinke*—which include the States of Texas, Indiana, and Louisiana—have brought a lawsuit against Interior Secretary Ryan Zinke and other Federal Defendants in the United States District Court for the Northern District of Texas (N.D. Texas), requesting the court to declare that certain sections of the Indian Child Welfare Act of 1978 (ICWA) ((Pub. L. 95-608, 92 Stat. 3069, enacted November 8, 1978) codified at

25 U.S.C. § 1901 et seq.) are unconstitutional, and to set aside the Department of the Interior's 2016 ICWA regulations as unlawful; and

WHEREAS, four Tribes have since intervened as Defendants: Cherokee Nation, Oneida Nation, Quinault Indian Nation, and Morongo Band of Mission Indians; and

WHEREAS, the Association on American Indian Affairs, National Congress of American Indians, and National Indian Child Welfare Associations are seeking signatories to an Amicus Curiae Brief in support of Defendants that (1) explains why ICWA was enacted and its continuing relevance today, (2) demonstrates how ICWA operates as an example of cooperative federalism to promote the best interests of Indian children, and (3) defends the constitutionality of ICWA; and

WHEREAS, Tribal Council is committed to the welfare, care, and protection of Indian children and families and the exercise of the Tribe's rights and responsibilities under ICWA.

NOW THEREFORE IT IS RESOLVED, that the Tribal Council hereby authorizes the Unified Legal Department to include Little River Band of Ottawa Indians as a signatory on the Amicus Curiae Brief in Support of Defendants in *Brackeen v. Zinke*, No. 4:17-cv-00868 (N.D. Texas).

Ratification of Sub-Contractual Agreement between the Inter-Tribal Council of Michigan, Inc. And the Little River Band of Ottawa Indians for the Head Start & Early Head Start Program

- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is vested with the authority, under Article IV, Section 7(b), to ratify contracts to be entered into by the Tribe; and
- WHEREAS, the Tribal Council has received a sub-contract from the Inter-Tribal Council of Michigan, Inc.; and
- WHEREAS, the contract has been reviewed, edited and approved by the LRBOI Unified Legal Department; and

WHEREAS, nothing in this Contract shall be construed to be a waiver of the sovereign immunity of the Little River Band of Ottawa Indians or any of its subordinate enterprises or entities and

WHEREAS, Venue for any dispute arising out of this Contract shall be the Little River Band of Ottawa Indians Tribal Court. This Contract, and any disputes arising out of this Contract, shall be governed by the laws of the Little River Band of Ottawa Indians.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogema to execute the Agreement with the Inter-Tribal Council of Michigan, Inc. incorporating the contents of this resolution.
