OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on May 4, 2022. Following are the minutes of that meeting. The audio for this meeting was filled with static and most of it couldn't be heard clearly from the ZOOM recording. The following is what was heard.

There were comments in the background on the ZOOM recording but it couldn't be made out clearly what they were saying or who said it.

Chelsea Densmore, Tribal #3225, said she doesn't know if she is interrupting and she is really sorry if she is she was jut trying to tell them guys their audio is coming through really um, quiet and disconnected. Densmore said she doesn't know if anybody else is hearing that via ZOOM but um, the audio seems like it is really off definitely on her end today.

Speaker Wolfe thanked Chelsea Densmore but the ZOOM recording didn't pick up what she said clearly in the background.

It sounded like Speaker Wolfe said Martha Howell.

Venus Wilson-Torres came into the Lodge Room at 10:06 a.m.

Speaker Wolfe said hello. Wolfe's voice came through loud and clear.

Martha Howell said that was better Julie.

Venus Wilson-Torres left the Lodge Room at 10:07 a.m.

Speaker Wolfe said they have none.

B. Budget Modifications

1. Acceptance of contract funds from the Department to Health and Human Services-Indian Health Services and approving a Modification to the Operating Budget MB-2022-__ in the amount of \$473,784

Acceptance of funds.

Speaker Wolfe said this is being brought forward by the Tribal Ogema with designee Bill Willis. Wolfe said Bill Willis has approached the podium and she will turn it over to him for overview of the item.

Bill Willis, Budget Coordinator, represented this agenda item. Willis thanked them. Willis said as he explained to Council in Agenda Review on Monday these funds represent the initial award under the Tribe's 2022 Self-Governance Compact with the Indian Health Service. Willis said one of the questions that he was asked to clarify he guessed today was a part of the awards they get from IHS they get um, Contract Support Costs both Direct and Indirect. Willis said the best way he can explain the difference between the two is Direct Contract Support Costs is designed to support ah, those staff people that directly um, work in the program for example their salaries and stuff like that. Willis said then the Indirect is associated with um, programs that support that department for example Accounting, HR, IT and so that's the primary difference between the two. Willis said he believed that Indian Health Services the only Federal Agency that provides both Direct Contract Support Costs and Indirect Contract Support Costs so. Willis said hopefully that explains it a little bit better especially for the Tribal citizens that may be on the.....on the call so.

Speaker Wolfe thanked Bill Willis. Wolfe asked did he want to go over the awards amounts and which departments this total allocation is going into.

Bill Willis said sure. Willis said um, as far as this award goes um, the funding is split between um, PRC-Preferred and Referenced Care, Clinic Operations and Behavioral Health better known as Be Da Bin. Willis said um, so as far as ___ goes ah, ah, PRC is getting \$58,741 of base funding, and is also getting \$168,817 in

um....let's see here and make sure he has got this correct.....okay he is sorry. Willis said ah, PRC is getting \$168,817 in direct base dollars and then on top of that their getting \$58,741 in Indirect Cost dollars. Willis said ah, 4104 which is Clinic Operations is getting \$185,403 in base funding and an additional \$47,404 in Direct Contract Support Cost dollars. Willis said then lastly Be Da Bin or Behavioral Health is getting \$13,419 of base funding so. Willis said they just need to accept the money and amend the Operating Budget.

Speaker Wolfe thanked Bill Willis for his introduction. Wolfe asked is there any abstentions on the item. Wolfe said okay, seeing none she will open it for discussion with Tribal Council. Wolfe said just to note again for clarification this is the initial award for the 2022 Fiscal Year from Indian Health Services, correct.

Bill Willis said that is correct.

Speaker Wolfe said its under the Self-Governance Compact.

Bill Willis said that is correct.

Speaker Wolfe said okay. Wolfe asked any additional comments or questions by Tribal Council. Wolfe said it is open for comments or questions by Tribal members. Wolfe said seeing none she would entertain a motion on the item.

Councilor Guenthardt said he will make a motion. Councilor Guenthardt couldn't be heard making the motion but due to the roll call sheets the motion was clear.

Speaker Wolfe said this is being brought forward by the Tribal Ogema with designee Bill Willis. Wolfe said to Bill Willis she will turn it over to him for introduction of the item.

Bill Willis, Budget Coordinator, represented this agenda item. Willis thanked her. Willis said this is actually.....this item represents Modification #1 to the 2022 Self-Governance Compact with IHS. Willis said these are funds in addition to their um, allocation which was Item 1. Willis said this breakdown is um, Preferred and Referenced Care getting \$203,197 in base funding and they are also getting \$70,704 in Indirect Contract Support Cost dollars. Willis said then Clinic Operations is receiving \$219,445 in base funding and an additional \$57,058 in Indirect.....or Direct Contract Support Costs. Willis said then lastly Behavioral Health is getting \$16,153. Willis said so for a total of \$566,557 ah, again, just need to accept the funds and amend the Operating Budget.

Speaker Wolfe thanked Bill Willis for the introduction. Wolfe asked are there any abstentions from Tribal Council. Wolfe said seeing none she will open it up for discussion with Tribal Council. Wolfe said Councilor Champagne go ahead.

Councilor Champagne's microphone wasn't working and her questions wasn't picked up clearly on the ZOOM recording.

Councilor Champagne asked he said this in relation to Item 1....

Bill Willis said yeah, these....

Councilor Champagne continued....so is this.....

Bill Willis said well, these funds come through much like Bureau of Indians Affairs money....they come through in different allocations throughout the course

of the year. Willis said the first item....Item #1 was the initial funding and then each funding received subsequent to that they consider a modification to the award.

Councilor Champagne asked how modifications do they receive in a year.

Bill Willis replied sometimes it could be eight or ten. Willis said it depends on how they appropriate the money or decide to send the monies so um, she will notice on the next item...the next item is only \$460. Willis said they know they are piecemealing this money to them and he doesn't know why they do that but...

Councilor Champagne said so they really don't know how much money they can expect they will send.

Bill Willis said well, um, they do during the Budget process go for example on the BIA Website they have a thing called the Green Book and so when they begin their Budget Process for the upcoming year they can go on the BIA Website and there is some numbers on there that are proposed numbers and they tend to use those as a base of how much they can potentially receive in that upcoming fiscal year so IHS is much simpler so um, they know, more times than not they end up getting more money than they Budget or project in their Operating Budget so that is always a good thing. Willis said yeah, they piecemeal this money and they have done it for as long as he can remember um, right....

Councilor Champagne made a comment but this one wasn't picked up on the ZOOM recording clearly.

Bill Willis said yeah, yeah. Willis said she is welcome.

Speaker Wolfe said okay, any additional comments from Tribal Council. Wolfe said she will open it up for comments or questions from Tribal members. Wolfe said seeing none she will entertain a motion on the item.

Councilor Guenthardt said he will make a motion.

Speaker Wolfe said go ahead, Councilor Guenthardt.

Willis said ah, as he mentioned they have a tendency of piecemeal....piecemealing the money um, this one is \$460 it's tagged as being for ah, purchase of equipment ah, under Purchase and Referenced Care so um, again just need to ah, accept the money and amend the Operating Budget.

Speaker Wolfe thanked Bill Willis for his introduction of the item. Wolfe asked any abstentions on it. Wolfe said seeing none she will open it up for discussion with Tribal Council. Wolfe said seeing none she will open it up for discussion with Tribal members. Wolfe said not seeing any hands raised she will entertain a motion on the item. Wolfe said Councilor Lewis go ahead.

5. Acceptance of contract funds from the Department of Health and Human Services-Indian Health Services and approving a Modification to the Operating Budget MB-2022-__ in the amount of \$1,647,845

Acceptance of funds.

Speaker Wolfe said this is being brought forward by the Tribal Ogema again with designee Bill Willis. Wolfe said to Bill Willis she will turn the floor over to him.

Bill Willis, Budget Coordinator, represented this agenda item. Willis thanked her again. Willis said ah, this item represents Modification #3 to the 2022 Self-Governance Compact with Indian Health Services. Willis said the breakdown is as follows ah, Preferred and Referenced Care is receiving \$591,004 ah, additionally they are getting \$205,645 in Indirect Contract Support. Willis said Clinic Operations is receiving \$638,260 with an additional \$165,956 in Direct Contract Support Costs. Willis said lastly Behavioral Health is receiving \$46,980. Willis said ah, in year to date with this award it brings them up to \$2,688,186 ah, there is a very good chance that they will continue to receive additional funding from them throughout the course of the year. Willis said again, just need to accept the money and amend the Operating Budget.

Speaker Wolfe said thanks for his overview of the item. Wolfe asked any abstentions. Wolfe said seeing none she will open it for discussion with Tribal Council. Wolfe said Councilor Champagne.

Councilor Champagne said she has question for him since he doesn't know how much they are going to get but can make assumptions.....the rest of her comment was not heard clearly on the ZOOM recording. Champagne asked have they ever been overpaid by Indian Health Services....the rest of the question was muffled and couldn't be heard clearly on the ZOOM recording.

Bill Willis said there has been some cases where they have had to ah, for example pay back Contract Support Costs money ah, because IHS in and of itself has a separate....what happens is the Tribe works out and submits an Indirect Costs Proposal ah, annually and negotiates a rate, right. Willis said what was happening prior to the ah, Class Action Suit that the Tribe has brought against BIA and subsequent IHS was that the Federal Government was negotiating these rights but wasn't paying the Tribe the entire amount of the negotiated rate and so the Tribe took them to.....they went all the way to the Supreme Court and the Tribes won and so um, so the Federal Agencies has been much better at giving them these Contract Support dollars. Willis said part of the challenge with IHS is they internally they have their own process where they like ask for additional information after the year has passed to kind of reconcile on their end these numbers and sometimes which tends to cause a little bit of confusion for him because his understanding is that is what they owe for Indirect Costs Proposal Processes all about is leveling that out over the course of years. Willis said but um, other than that no, what typically happens is ah, money that doesn't get used either through the BIA Contract um, Self-Governance Compact or IHS is that money then gets put into deferred revenue which they know shows up on the financials um, that Council is presented monthly so um, and those dollars sit there until they are reallocated for other purposes that Council authorizes so. Willis said um, other than Contract Support Costs he doesn't never think they paid back direct base funding to IHS for any reason um, it just gets given to the Tribe until they spend it so. Willis said that is kind of a long answer but....

Councilor Champagne said she was just curious because she thought that if they were ever asked to pay back....the rest of her comment faded off and sounded muffled on the ZOOM recording.

Bill Willis thanked them.

Speaker Wolfe said okay, it is still open for discussion with Tribal Council. Wolfe asked Bill Willis if they had a year to date amount.....year to date amount of the award they have received.

Bill Willis asked for IHS.

Speaker Wolfe said um-hum, the IHS.....the rest of the comment was lost because they were both speaking at the same time on the ZOOM recording.

Bill Willis said he thought he read that into the record but he will read it again. Willis said year to date ah, with the awards from IHS 2022 Self-Governance Compact....yeah, the total year amount date.....year to date amount is \$2,688,186 so.

Speaker Wolfe said okay, and thanked him for that. Wolfe asked any additional comments from Tribal Council. Wolfe said it is open for discussion with Tribal members. Wolfe said seeing no hands raised she will entertain a motion on the item.

Councilor Guenthardt said he will make a motion.

Department. Wolfe said the Legislative Tribal Council passed a resolution that

C. Legislative Affairs Update

Speaker Wolfe said this is open for Tribal Council if they have any comments. Wolfe said Councilor Di Piazza.

Councilor Di Piazza said just a reminder the 30 Day Comment for the 1836 Hunting & Gathering and Trapping Regulations are....will be up this Saturday so. Di Piazza said get their comments in and ah, happy hunting. Di Piazza said that is it.

Speaker Wolfe said okay, and the only other note for Legislative Affairs the Natural Resource Department in conjunction with the Community Volunteers from the Sugar Bush Season are sponsoring a Pancake Breakfast that is happening on um, Saturday, May 15th she thinks it begins at 9 a.m. and it is going to be held at the Aki Maadiziwin Community Center. Wolfe said there is a flyer posted on the Government Website.....she means the Government Face Book for more information or they also could contact Natural Resource Department if they want more information. Wolfe said um, anyone else for Legislative Affair Update. Wolfe said okay, seeing none that brings them onto D.

D. Public Comment Period

Speaker Wolfe said she will open it up to Tribal membership. Wolfe said first in the queue she sees Sara Agosa with her hand raised. Wolfe said she has the floor.

Sara Agosa, Tribal #4478, said her first comment is regarding the item from last week about the purchase of um, air units with ARPA Funding and she thought about it and she would like to share her opinion with Council that she really has an issue with how Tribal members were virtually threatened that their Per Capita would be impacted if this ARPA Funding wasn't used for this purchase because

the casino makes millions of dollar....dollars annually and they also have an Economic Development Corp that is supposed to improve the economic condition of the Tribe also organizational assessments have been done but never implemented. Agosa said at this point their Per Capita should be going up and definitely not reduc....reduced and most certainly not threatened over Capital Purchases and she would just like to remind Council that they also don't give a Per Cap to use so she highly doubts that any other Tribe in the area that Tribal members come to meetings and their Per Cap is threatened over a Capital Purchase its not fair nor does it seem logical with the millions of dollars and assets that the Tribe owns. Agosa said she would also like to share that there are a few outlying members that are able to come to these meetings and share opinions and they have the right to share their opinions whether their casino management agrees with it or not. Agosa said this is a Tribal Council Meeting open to the public and with that being said she would like to thank the Speaker for conducting these meetings and doing a very good job and being open to comments. Agosa said she does have one final comment on a different subject. Agosa said she found an article title Muskegon County Tribal Casino Project trying opposition on several fronts it was issued on May 21st, 2021 and she would like to quote to the Ogema Larry Romanelli "It's really time to move this to the final stages Romanelli told Wood that means that the Governor signs off and the Legislator also needs to sign off and they really need to get this thing moving they are in some terms shovel ready." Agosa said so her question to Council is has the Legislators signed off on this Casino Project. Agosa thanked them. Agosa said that is her question.

Speaker Wolfe thanked her for her comment. Wolfe asked any response from Tribal Council.

Councilor Di Piazza said yeah, he's good in the background on the ZOOM recording.

Councilor Guenthardt left the Lodge Room at 10:45 a.m.

Speaker Wolfe said okay, at this point there is no response from Tribal Council and her own personal opinion being a newest Council seated here for only nine months she does not believe the Legislator has signed off on the documents but that could be determined um, so that is a response from Tribal Council on her question. Wolfe said next in the queue they have citizen Rebecca Liebing. Wolfe said she has the floor.

Rebecca Liebing, Tribal #2878, it is great to see them guys back in the Lodge Room. Liebing said she hasn't been able to come to a meeting since she started her new job but she hopes in the future she will be able to come to a few more. Liebing said her comment to Council is there is a lot of money coming through in the Infrastructure Bill from the Federal Government and a lot of potential grants and she is wondering if Council would consider doing a membership survey. Liebing said they did it, she doesn't know, maybe like a decade ago they paid

Tribal members a certain amount of money and they got a bunch of information that could be used to create programs um, a lot of that information is helpful when like applying for grants and so she would be willing as a citizen to send them some samples of survey questions and even some language to create the program um, because she thinks it really could be beneficial to the Tribe when its trying to get grant dollars. Liebing said um, so she will.....they know them guys to sort of follow-up she just wanted to put that on the record.

Speaker Wolfe said okay, thanks for her comments. Wolfe said she thinks she might have all of Tribal Council's emails so.

Tribal Councilors were all laughing.

Speaker Wolfe said they appreciate that Rebecca. Wolfe said she knows it has been discussed or talked about possibly or potentially a survey that goes out after they bring on these Communications positions so they have input and can develop that and help Tribal Council get it dispersed. Wolfe said so thanks for her comments and they appreciate what she will send forward and they will review that. Wolfe said next in queue they have she believe it is Mike Burmeister. Wolfe said he has the floor.

Michael Burmeister thanked Speaker Wolfe. Burmeister said number one they didn't....he doesn't believe nobody threatened Per Cap that is just a fact of life if they spend money here the less money goes over to the Tribe and Distribution and that is a fact of life. Burmeister said he understands this is a Tribal Council Meeting but anybody that speaks here is also a Tribal member and he thinks that everybody could be reminded of that. Burmeister thanked them.

Speaker Wolfe said they didn't hear a lot of his comments. Wolfe thanked him for his comments Mr. Burmeister. Wolfe said next in the queue is Councilor Di Piazza. Wolfe said he has the floor.

Councilor Di Piazza said he just wanted to say Miigwech ah, Rebecca for being online its good to hear her voice. Di Piazza said he is glad she is doing extremely well. Di Piazza said that's it.

Councilor Guenthardt re-entered the Lodge Room at 10:48 a.m.

Speaker Wolfe said okay, seeing no one else in....oop, Ogema Romanelli. Wolfe asked does he have a comment.

Ogema Romanelli said yeah, he just wanted to respond to ah, Rebecca Liebing's suggestion he thinks it is a great idea. Romanelli said as they know there is different monies coming in since COVID and ah, he thinks it is a good idea to reach out to the membership to see what they have in mind and to give them some

guidance. Romanelli said so he just wanted to follow-up with that. Romanelli thanked them.

Speaker Wolfe said okay, thanks for his comment. Wolfe said she sees no one else in the queue under Public Comment so again that brings them to Closed Session.

The purpose of closed session is to discuss business matters considered privileged or confidential involving consideration of bids/contracts, pending legal issues, and/or personnel matters.

Speaker Wolfe said she will entertain a motion to end First Open. Wolfe said Councilor Wittenberg.

Councilor Wittenberg said yes, he would like to make a motion.
