1. Approval of Grant Application Request to the U.S.
Department of Labor (DOL) H-B1 Rural Healthcare Grant
Program to alleviate healthcare workforce shortages by
creating sustainable Employment and Training Programs in
Healthcare Occupations (including Behavioral and Mental
Healthcare) serving rural populations

The DOL has release rural healthcare work force development funding with awards ranging from \$500,000 to \$2.5 million to use over a 4-year period. Funds can be used to hire and train Behavioral and Mental Healthcare Workers. There is no cost share

2. Approval of the Natural Resources Department Grant Application to the United States Environmental Protection Agency for a Community Wide Brownfield Assessment Grant for Fiscal Year 2021 to Fiscal Year 2023

The Natural Resource Department is submitting a grant application for Brownfield Assessment Funding for a funding total of \$71,200 to assess a minimum of 3 parcels in Manistee County. A part of this grant includes redevelopment plans for each of the parcels proposed and these plans will be developed through community wide

outreach.
