I refuse to allow continued rumors to be spread within this tribe. I've watched this happen for over a decade especially around election times. From the email I string below, I received very few responses from tribal council and EDC. I could give a damn about what is said about me, it comes with the position, but I know that there are people who are intentionally misleading tribal membership. From the emails below, I asked for someone to explain where the \$850,000 went. Council should know and Councilor Crampton was on council when the fishing program was started, I believe he is the only one on council that was on back then. Not a word from him. He and others should know the money trail and where the \$850,000 ended up. Carlene is an outlaying member; an outlying rep should answer her. Why would council reps leave her to believe incorrect information?

Preference in hiring. I keep hearing about that, and I guess what is the problem? I did not make the decision to layoff employees by myself. Actually, directors and Leads made the list and presented the list to me. Rumors that tribal employees were replaced by non-tribal employees; really? By me? where?

Misstatements of me not letting Janine Sam or others get a job or on committees or commissions was just completely false. Why are those statements allowed to continue?

The whole issue with my heritage continues to this day with Councilor Champagne still saying that I am not Native American, yet she fails to show the proof. In an open session of Tribal Council Meeting, Shannon stated that he was told by some "auties" that there were people running in this election that aren't Native American but doesn't say who the "auties" are or who the supposed candidates are. As usual. He has made similar statements since I've been ogema. Why is he not expected to back up his statements?

I know that many of you know the truth behind most of these misstatements, feel free to help correct them.

the tribal council would know that I have not received one nickel from this tribe for my construction company over the years. I never even bid on any job. Quite frankly, I wouldn't because of all the BS that would come with it.

Spending the 7th generation's inheritance? Are we serious? As Council pushes giving 50% rather than 40% out now for per cap?

If this is what it takes at every election, it's no wonder our Tribe has a hell of a time trying to get ahead or move forward. If we don't knock down the continual rumors, we're sunk. We have at least one current councilor, Councilor Champagne, making the statement, after 14 years, of me not being "Indian". Councilor Crampton making similar statements of people running for office in this election possibly not being Indian; with no kind of backup to those statements. Has anyone held them accountable? Has council asked them to produce documents on their accusations? Is this really who is leading our Tribe?

Unbelievable. In any other organization, people who spread lies would be removed from the organization. Why do we accept less for our Tribe? It's time for all good people to speak out.

Per our earlier phone conversation, below is what corresponded during the phone call with Ms. Sara Agosa. During the call with Ms. Agosa, she wanted to know if the Ogema's two businesses where in the tribe's preferred vendor file.

I explained that there are two different types of vendor files. The first is a list of vendors that the tribe has done business with and a second list is a list of vendors that have been certified as having Indian Preference by the Tribe. I told her that both businesses were certified by the Tribe as having Indian preference, but at no time have we received a quote or an award made to either company. I further noted that both certificates had expired.

I further explained how Indian Preference works. She inquired the names of the two businesses. I told her I had to look those up. This is when I had called you.

I called her back and gave the names of the two businesses.

Ms Agose inquired on what types of businesses were they were. I responded that I didn't feel comfortable in providing any detailed information on any company on file without consent from the company. She stated that she can get the information from another source.

She called back a third time and told me that she wanted me to know that she keeps her sources private.

She was very cordial and polite during the calls.
