At such a hearing, you will be required to show why this Court should not enforce the Foreign Judgment. Conditions for recognizing and enforcing a judgment of a court of another State has been established by Little River Band Tribal Court Rules and Michigan Court Rules. Under those principles, a court of one state will enforce a foreign judgment if (1) the judgment is final between the parties; (2) the court that granted the judgment was competent to do so and had jurisdiction over the parties; (3) regular proceedings were followed that allowed the losing party a chance to be heard; (4) no fraud was worked upon the first court; and (5) enforcement will not violate the public policy of the enforcing state. The entry of such an order enforcing this judgment shall entitle the judgment holder/creditor to enforce its judgment against you in any manner currently available for judgment holders/creditors in the Tribal Code.
