**Position: Seasonal Fisheries Technician (Temp. - Natural Resources Department) – (5)\***  
**\*Revision Additional Technicians added to prior posting from 1-02-2019 – Total of 5 positions to be filled.**

**Summary:** This seasonal position will be assist the Fisheries Program with fieldwork, laboratory and data recording duties. This position will include extensive fieldwork, equipment upkeep, extensive driving, technical reports, and may involve data entry. This position requires flexibility in scheduling which includes late nights and weekends. **Note:** The position is temporary, full-time not to exceed 89 days worked.
