The Partial Final Report for the 2021 Regular Election is forward, pursuant to the Election Ordinance, #08-200-02, Section 6.01, by the Little River Band of Ottawa Indians Election Board to the Tribal Ogema, the Speaker and Recorder of the Tribal Council and the Tribal Court.

The Election Board certifies the following partial results for the April 30, 2021 Regular Election. The Election Board is certifying a partial Final Report because of the filing of election challenges and disputes concerning the results of the Office of Tribal Council-Outlying, the Office of Tribal Council-9 County, the Office of Tribal Council At-Large, and the Election Board. The Election Board is exercising its authority and discretion to certify the results and provide a partial Final Report for the Tribal Courts offices for the April 30, 2021 Regular Election to allow for the orderly and timely succession of the Tribal Court. The Election Board will submit a second, partial Final Report concerning the Office of Tribal Council-Outlying, the Office of Tribal Council-9 County, the Office of Tribal Council At-Large, and the Election Board when the challenges and disputes concerning those offices have been resolved.
