Request for Fiscal Year 2020

The Food Distribution Program is making their Annual Budget Request to USDA to manage their program. The Request is for \$243,145 of which there is a 20% In-Kind Tribal Match.

Speaker Pete asked Lyle Dorr if he was here to support this.

Lyle Dorr, Grants Department, represented this agenda item. Dorr said he is. Dorr said he is filling in for Ken La Haye who is on leave today. Dorr said this is just an annual submission to the Budget and it is considered a grant so that is why he can know about it and can fill in for him. Dorr said the match in it dropped from 25% this year down to 20% per legislation and so that is what the submission is for the \$243,145.

Speaker Pete thanked Lyle Dorr. Pete asked this is a 20% drop so roughly their obligation will be in the neighborhood of \$46,000 or something like that the rest would be grant funded for food right.

Lyle Dorr replied correct. Dorr said it is actually the Budget is a little bit more than last year but the match actually stays about the same because of the drop in the requirement.

Recent Case Law articulated the importance of Tribal Councils recognizing their Economic Development Corporations as critical arms of the Tribe for Sovereign Immunity purposes.

Tyler Leppanen, Assistant EDC Director, represented this agenda item.

Councilor Crampton in the body of the document itself the last "WHEREAS therefore Tribal Council confirms its continued support for the actions, existence, need and role of Little River Holdings, LLC (EDC) as the parent economic development entity of the Nation, which acts as the direct link between related entities and subsidiaries including Little River Government Contracting, LLC, Little River Capital Management, LLC, Little River Real Estate Management, LLC, Little River Health Technologies, LLC, Little River Development, LLC, and the will of the Tribal Council and Ogema." Crampton said now his question is that doesn't expand where they are supposed to be confirming duties that they already have that already exist. Crampton said this document does not expand any of those does it.

Tyler Leppanen said not to his knowledge. Leppanen said Tom St. Dennis' intention was to mirror the case, recent case law, just to protect the Tribe's sovereign immunity for the businesses that the Tribe owns.

Councilor Crampton said um-hum. Crampton said he just wanted to get that on the record because if it gets argued that they know the intent now if it gets argued later that it expanded duties. Ogema Romanelli said right.

Speaker Pete said so they never know but at any rate. Pete thanked the Ogema again.

Ogema Romanelli said they try and keep, they know, this same time every year so that people can plan their vacations and their travel. Romanelli said they always keep it after they receive their Per Cap because that was one of the main complaints if they had it before Per Cap was out they said they need their Per Cap to attend the meeting so. Romanelli said usually they go a little later and they are better off so that's what. Ogema Romanelli said yeah it is. Romanelli said it will probably be moved one way or the other and it looks probably the 18th is tentatively.
