#### REPEALING GAMING COMMISSION REGULATION - CHAPTER 3

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C.§ 1300k et seq.); and

WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council has, pursuant to Gaming Commission Ordinance #04-400-04, created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Triba and to enforce all Tribal and federal laws governing the conduct of Tribally-licensed gaming activities; and

WHEREAS, Section 6.04 (a) of the Gaming Commission Ordinance permits the Gaming Commission to promulgate regulations and internal operational procedures of the Gaming Commission and its staff; and

WHEREAS, the Gaming Commission created and approved Resolution #GC01-05-16-02 affirming commission regulations in effect as of May 16, 2001; and

WHEREAS, the Gaming Commission has determined that the Gaming Commission Regulation – Chapter 3 – Hours of Operation content should be added to Gaming Commission Regulation – Chapter 4 – Notifications and Reports; and

NOW THEREFORE IT IS RESOLVED THAT the Gaming Commission hereby repeals Gaming Commission Regulation – Chapter 3 – Hours of Operation and authorizes the use of Chapter 3 for newly proposed regulations; and

IT IS FURTHER RESOLVED THAT the Gaming Commission will add the repealed language from Chapter 3 – Hours of Operation into Gaming Commission Regulation – Chapter 4– Notifications and Reports.

#### REVISING AUTHORIZED DESIGNATED PURCHASING AUTHORITY

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C.§ 1300k et seq.); and
- WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band of Ottawa Indians and its members; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(I) to take action, not inconsistent with the Constitution or Federal law, which is necessary and proper to carry out the sovereign powers of the Tribe; and
- WHEREAS, the Tribe's Budget and Appropriations Regulation #R100-01:AC-01 Chapter 1 Purchasing and Procurement Section 3-2 designates the authority to purchase; and
- WHEREAS, the Tribal Council in Gaming Commission Ordinance #04-400-04, created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Triba and to enforce all Tribal and federal laws governing the conduct of Tribally-licensed gaming activities; and
- WHEREAS, Gaming Commission Ordinance Section 6.03 (a) states the Gaming Commission budget shall be in conformance with the policies of the Tribe in regards to the expenditure of tribal funds and that the Tribal Council shall determine and approve on an annual basis the appropriate spending level authority of the Gaming Commission; and
- WHEREAS, the Gaming Commission Ordinance Section 6.04 (a) (1) states that the Gaming Commission shall promulgate regulations consistent with the Gaming Commission Ordinance and necessary to carry out the orderly performance of its duties and powers which shall include internal operational procedures of the Gaming Commission and its staff; and

- WHEREAS, the Gaming Commission established an authorized designated purchasing authority by resolution #GC14-0805-18 on August 5, 2014 and was further approved by Tribal Council Resolution #14-0820-258 on August 20, 2014 by; and
- WHEREAS, the action amount that the Gaming Commission has authority to sign off on has also been modified increasing it up to \$25,000.00 to keep it copasetic with the Tribe's Budget and Appropriations Regulation #R100-01:AC-01 Chapter 1 Section 3-2; and
- WHEREAS, in accordance with the Gaming Commission By-Laws Section 2.02 (b) (2), the Secretary shall be responsible for fulfilling the responsibilities of the Chairperson in the absence of the Chairperson.

NOW THEREFORE IT IS RESOLVED THAT the following structure for designated purchase authority is hereby established for the Gaming Commission:

- a. <u>Actions \$0.01 to \$500</u> Surveillance Manager, Compliance Manager and Senior Internal Auditor authorized to sign off on purchases and encumbrances.
- b. Actions \$0.01 to \$2,500 Executive Director and/or Chairperson authorized to sign off on purchases and encumbrances.
- c. <u>Actions \$2,500.01 to \$12,000</u> Executive Director and Gaming Commission Chairperson authorized to sign off on purchases and encumbrances.
- d. Actions \$12,000.01 and \$25,000 Gaming Commission approval by resolution.
- e. <u>All actions \$25,000.01 and greater</u> Gaming Commission approval by resolution and Tribal Council approval by resolution.

IT IS FURTHER RESOLVED THAT the Gaming Commission will incorporate this action in its By-Laws and internal operating procedures upon approval by Tribal Council.

<sup>\*</sup> Executive Assistant supports/assists the Executive Director in the vendor licensing process which includes (not inclusive) the following: initial contact with vendor (and control person(s) when applicable) explaining the application process and requirements; performs cursory review of application and attachments upon return to ensure completeness; initiates investigation; runs Dunn & Bradstreet Reports; conducts license verifications; processes personal reference checks, etc. Also prepares all renewal and initial licensing application letters and sends out licensing application packets; responsible for tracking vendor licensing information to ensure no vendor's license expires without the appropriate notification being sent to the vendor/licensee. Upon completion of all above, the entire file is provided to the Executive Director for review prior to placement on the Gaming Commission Meeting agenda for review and consideration.
