## Approving the FY2020 Budget for the Gaming Commission Administration, including Surveillance in the Amount of \$2,082,862 plus Insurance Benefits and Other Administrative Costs

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C.§ 1300k et seq.); and

WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band of Ottawa Indians and its members; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(I) to take action, not inconsistent with the Constitution or Federal law, which is necessary and proper to carry out the sovereign powers of the Tribe; and

WHEREAS, the Gross Gaming Revenue Tax Ordinance #09-100-05 requires proceeds from the gross gaming revenue tax be used as the top priority to fund all regulatory costs incurred by the Tribal Gaming Commission ("Regulatory Agency"); and

WHEREAS, the Tribal Council adopted Gaming Commission Ordinance #04-400-04 which created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Triba and to enforce all Tribal and federal laws governing the conduct of Tribally licensed gaming activities; and

WHEREAS, the Gaming Commission Ordinance #04-400-04 authorizes the Gaming Commission to employee such staff as may be required to fulfill the Gaming Commission's responsibilities of the Ordinance; and

WHEREAS, the Gaming Commission Ordinance #04-400-04 authorizes and holds responsible the Gaming Commission to arrange for training of Gaming Commissioners, Gaming Commission employees, and others in areas relating to the regulation of gaming.

NOW THEREFORE IT IS RESOLVED THAT the Gaming Commission hereby approves the FY2020 Budget for the Gaming Commission Administration, including Surveillance in the amount of \$2,082,862 plus insurance benefits and other administrative costs.
