E. Law Enforcement Update:

Brown- Powwow success – Campground has influx of member, couple of citations for alcohol. Conservation Officers went to Minnesota for wildlife forensics class. Lots of discussion on human attacks and how agencies respond. Bear vs. Dog in Bear Lake, dog died. Bears are moving into our area. Dept. needs educational/info materials for distribution. Brown went to White Earth to represent at a funeral for a fallen officer.

Virgil asks about:

CWD transitioning to humans? Brown says no confirmed reports. Hunter Safety Class for members this year? Brown says, Yes. Virgil wants to be involved.

Discussion of Baiting: How the State does it and what proposals is the State making for Bear? Proposals for Walleye and Perch, we need to know.

F. Natural Resources Department Update:

Frank – Opening increasing acres, increase leaser for Zilwinski. Virgil wants to know soil conditions at the corner by the WWTP. Work session- invasive species – wild olives being removed, trying to get all invasive plants removed. Schedule work session w/council for strategic plan for NRD.

G. Legal Dept. Update:

Elyse – saw 2 bears. Working on 20/20 Consent Decree in confidential stage atm. asking for suggestions to look over and include. Gear restrictions need to be looked at; other Tribes are looking at it. Trap Nets – need to get away from, other Tribes want Gillnets. Bi-Catch limits inland vs. Lake Michigan. Asking for proposals for Consent Decree.

Commercial fishing business operations. Virgil talked to Tom St. Dennis about GTB loan program for fishermen. Would like to have commercial fishing program loan placed under the EDC.
