# HOUSING DEPARTMENT ACTIVITY REPORT For May 2017

#### 1. Housing Activities.

- A. The development of 10 more Fair Market housing at Aki continues to move forward. Concrete basement walls have been poured for about half of the units, forms striped and backfilled along the exterior walls.
- B. I have met twice this month with IHS seeking funding for the furnishing and installing the water and sanitary sewer lines from the mains to the residences and the cost of the water meters. IHS has indicated they believe this would be an allowable cost and that the funding would go through Members Assistance Well and Septic program. Linda Wisner will be working on this for us. The Construction Task Force has dedicated the funding to help offset the costs for landscaping which was not included in the Contractors proposal.
- C. Tribal Council has decided to seek Low Income Housing Tax Credits, LIHTC, for the development of an Elders Housing Complex at Aki. The consultant selected for this program is Travois. Since their selection the Housing Department is being included as part of the planning.
- D. The Housing Department sent out an information on how to prevent mold in our residential units, please see attachment #1.
- E. We also sent out a friendly reminder to residents to maintain their landscaping, see attachment #2.
- F. During the month the Department performed the following activities.

- C. Aki has 2 low income elder ADA designated rental units and 2 are rented.
- D. Aki has 28 low income family rental units and 25 are rented.
- E. Aki has 6 low income family ADA rental units and 6 are rented.
- F. Aki also has 12 fair market rentals and 12 are rented.
- **G.** We have 5 fair market rentals in the City of Manistee and 4 are rented.
- H. We also have 2 short-term rentals in the City of Manistee and 2 are rented.

#### TIPS FOR REDUCING THE LIKELY HOOD OF MOLD IN YOUR HOME

Boozhoo,

Hopefully we can say summer is almost here and with summer brings heat and high humidity.

Is that a concern? Yes, heat, high humidity and a food source promotes mold growth. Therefore we would like to provide you with some information to help prevent this from happening in your home.

Servpro has advised us there is over 30,000 different varieties of mold in Michigan. Fortunately the black mold, Stachybotrys, is not common in Michigan and mostly found in southern states as it requires long periods of high humidity and heat. Also mold comes in many colors and sometimes a black colored mold is mistaken for the "black mold".

What can we do to reduce the risk of mold this time of year?

Mold likes warm moist areas such as basements, crawlspaces, bathrooms, kitchens and areas where there is little air circulation.

Basements: Do not store items against the walls leave plenty of space. This will provide for air circulation along the walls and allow you to observe them. Put a fan in the basement and let it run to circulate air. Leave the air vents in the HVAC ductwork open and run the furnace fan, the switch should be on the thermostat, to provide more air movement in the basement and throughout the house. A dehumidifier works very well and may be necessary when the humidity is the highest, such as in July. If you see any moisture such as leaks in the pluming notify us immediately so we can eliminate that moisture source. Running your AC is an excellent source for reducing humidity, especially if you have the air vents open in the basement ductwork. Yes, that may cost a little more but it should be a good investment in your family.

Bathrooms: This area is a year round high moisture area. Run your ceiling exhaust fan when bathing, especially when showering, as it removes moisture from the room. Leave the shower curtain partially open after bathing so the shower can dry quicker. Let the fan run after you have left the room until all the moisture has been exhausted. Mirrors and/or windows are free from moisture.

Window openings: Believe it or not this is another area for mold growth. It is important to open all the window coverings daily so air can get in. Leaving the blinds closed all the time creates stagnant trapped air against the window which then is more likely to cause condensation on the window and therefore moisture for mold growth.

Cleaning surfaces: Mold needs three things to grow; food, humidity and heat. Therefore cleaning of all surfaces is essential to removing a food source. We have seen mold on plastic surfaces. The plastic itself is not a food source however when dust, fingerprints, etc. are allowed to accumulate you now have a food source.

You can do some research that should be able to provide you with more helpful hints to prevent mold in your home. These are just some things that come to our minds and we hope you find this helpful.

Be vigilant and notify us immediately if you see something suspicious.
