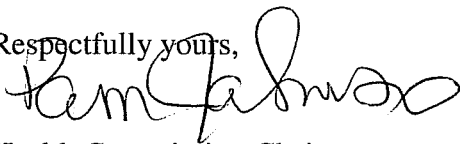
Name, Purpose, Officers:

DISCUSSION PERIOD:

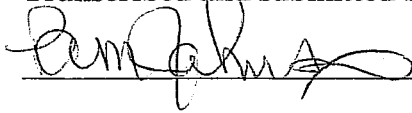
- Discussion on the clinic
