Frank handed out papers on rental rates of other Michigan tribes, waiting list for fair market housing at Aki and income based housing waiting list. Commission made assessment of Aki housing decided changes were needed. A list was made of the adjustments of rent and changes of the way things were being taken care of. Commission voted on the list of things to be changed. List will be taken to Council on September 1<sup>st</sup>. If they approve the increase of 17.5 it will go into effect October 1, 2016. Decision was made to ask for more fair market housing. Three or more bedrooms for family and 2 bedrooms for single family. It was decided rent would go up to 17.5 %then in July it will go up to 20 %.
