A. Adoption of the Revised FY 2018-2021 Little River Band of Ottawa Indians Tribal Transportation Improvement Plan (TTIP)



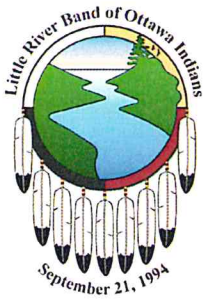
