These are two year grants but DOJ usually solicits new applications every year. If the grant is awarded MILS expects to receive approximately \$11,000 for Civil Tribal Court Services and \$14,000 for Tribal Court Criminal Defense Service and expect that some of these funds will be spent to provide services to LRBOI Members and/or in the LRBOI Tribal Court.
