Position: (1) – Head Start Bus Driver/Floater Aide (FT Regular - Family Services Department -NGLC)

SUMMARY:

Provide safe transportation of Head Start children and/or families for all program-related activities. Serve as support staff for all aspects of Head Start center operations. Assist teacher, helps plan and participates in classroom, playground, and field trip activities. Responsible for ensuring Head Start policies, procedures, goals and objectives are followed and met. Maintain attendance records and other detailed records. Ensure activities are designed to foster or enhance all areas of the child's development. Responsible for upholding the programs mission and values of the program utilizing NAEYC's Code of Ethical Conduct.
