REGISTRATION FOR TRIBAL MEMBER FUEL TAX EXEMPTION

Operational Rules and Procedures

1. Fuel tax discount is only allowed on fuel purchased for a Tribal member's personal use.
2. Tribal member must be at least 16 years old.
3. Tribal members must register their vehicle and license plate number with the Tax Office **before** obtaining the fuel tax discount.
4. The vehicle(s) registered with the Tax Office must be owned by the Tribal member or the Tribal Member's family.
5. Tax-exempt fuel may only be dispensed into a registered vehicle or one approved container not to exceed a capacity of 8 gallons.
6. A Tribal member who is unable to drive due to a disability may obtain authorization from the Tax Office to purchase fuel tax-exempt for the vehicle of a non-member spouse, family member or caretaker to provide transportation for the Tribal member. Please complete the designated Disabled Motor Fuel Registration form and requirements.
7. Fuel tax discount is **only** available at Little River Trading Post.
8. Tribal members **must** pre-identify themselves to the cashier and have their LRBOI Tribal picture ID with them. **NO PICTURE ID, NO DISCOUNT!**
9. Tribal member must complete sales log at Little River Trading Post. Log the Date, Tribal ID#, Name, Signature, License Plate #, and check gasoline or diesel box. Please write clearly and make sure your information is complete and accurate.
10. A Resident Tribal Member (RTM) **must** remove their "RTM" sticker on their Tribal ID card if they move out of the Tax Agreement Area.
11. Tribal member **must** keep track of their own tax-exempt gallons. Monthly limits will be enforced!
12. Penalties and/or suspension will apply for failure to follow tax-exempt motor fuel rules.
13. Fuel tax exemption program may be suspended by the Tribe at any time.
14. The Tribe may bar individual Tribal members from the fuel tax exemption
