



FDPIR: FOOD DISTRIBUTION PROGRAM

For Your Application to be “Certified” for the USDA Food Program:

Bring or Send **“COPIES”** of All the Following Information:

- ✚ 1 month of weekly, biweekly, part time check stubs for **“All” persons in household.**
- ✚ **Unemployment** statement and/or **check stub.**
- ✚ Statement of Monthly income you get in mail in December if you get **SSI/SS/Retirement** benefits etc.
- ✚ **MI Drivers License** - **MI ID**- **Tribal ID.**
- ✚ Bank Statement **only** if you have **Direct Deposit** for your SSI or SS Checks.
- ✚ Any other income in the household not listed.
- ✚ **Cancellation** or **Denial** from the **Snap Program** if it applies to household.
- ✚ **Current Rent Receipt** and or **Current Utilities Bill** for deduction on total monthly income.

We conduct a SNAP (Supplemental Nutrition Assistance Program) check list with the State of Michigan and Enrollment check list with your tribe; before your application can be certified. To complete application process **“All Required paper work”** must be with application.

Food Distribution Program is Federally Funded, they set the rules and guidelines for the USDA Food Program

Food Distribution Program offers USDA foods to Native American households. **NO households may participate in “BOTH” the USDA Food Distribution Program and Snap Program** in the same month. But eligible households can switch from one program to the other at the end of each month. Eligibility and participation for FDPIR are based on application and certification requiring tribal status, income and resources qualifications. To determine who is eligible to receive USDA Foods, there is a guideline on how much income each household can have to be eligible for the program.
