The physician will be responsible for diagnosing, prescribing medications, healthy lifestyle habits, and alternative options. The provider will also be exposed to alternative medical devices and working directly with a diverse medical team and staff at the Tribal Health Center in Manistee and Muskegon, Michigan.
