Purpose:

The purpose of the Privacy Policy is to define the privacy practices used by the Tribal Government in connection to the Tribal Government website and the data collected and maintained by the Tribal Government website.

Policy:

I. Information collected:

A. General Public website:

1. Information Collected Automatically - When you visit the LRBOI website, standard information is collected and cannot be used to detect you as an individual. The information collected is NOT personal information. It may include what pages were viewed and the amount of time that was spent at each page. It can also include your domain name, your Internet Protocol address, the operating system and browser you are using and how you reached this site. The information also tells how many times the LRBOI website is bookmarked for future visits. The purpose of collecting this information is used exclusively for statistically measuring the site traffic and to improve the quality and duration of all visits to the LRBOI website. Please note that this information is not viewed on an individual basis but rather viewed as a whole with all other visitors to this site.
2. Information Voluntarily Submitted - This information is voluntarily submitted to the Little River Band of Ottawa Indians through the website's fill-in form submissions.

B. Citizens Private website

4. Tribal ID Number.

II. Information is used for:

Any of the information we collect from you may be used in one of the following ways:

1. To personalize your experience
(Your information helps us to better respond to your individual needs)

(We continually strive to improve our website offerings based on the information and feedback we receive from you)
3. To improve customer service
(Your information helps us to more effectively respond to your customer service requests and support needs).
4. Registration validation for secure site.
5. To send periodic emails

III. Protecting your information

- A. We implement a variety of security measures to maintain the safety of your personal information when you access your personal information.
- B. We offer the use of a secure server. All supplied sensitive information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Database to be only accessed by those authorized with special access rights to our systems, and are required to keep the information confidential.

IV. Cookies:

- A. Cookies are used only if the Remember Me box is checked on the Login Page.

V. Disclosure of information:

- A. We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.
