Summary: This position will be responsible for assisting the Environmental Coordinator in managing the LRBOI Air Q u a I i t y Program by evaluating and monitoring the Air quality of the Tribal Reservation area. This position includes fieldwork, technical report writing and data analysis. This position is funded under a grant from US EPA.
